Opening Remarks By Cliff Kincaid, President, America's Survival, Inc.

We are here to demand that the corrupt Attorney General Eric Holder be removed from office. Holder lied about his role in granting pardons to terrorists under Clinton. Rick Hahn and Joe Connor will talk about this. We have also released, for the first time, a comprehensive report on the corrupt record of Eric Holder, written by investigative journalist Ron Kolb.

In addition to the granting of pardons or clemency to terrorists from the FALN and the Weather Underground, which Holder must answer for, the Obama/Holder Administration must be held accountable for the release from prison last year of Carlos Torres, the FALN co-founder, after serving 30 years of a 78 year sentence.

Equally offensive, Weather Underground and Black Liberation Army terrorist Marilyn Buck, a convicted cop-killer, was released. **We are revealing details of this for the first time here, through materials gathered through the Freedom of Information Act.** Incredibly, Buck's attorney, Soffiyah Elijah, cited Buck's "Master of Fine Arts in Poetics," completed behind bars, as evidence that she deserved parole. It's a fraud and a racket.

These poems, as Tina Trent documents in the report we have made available to you, are not only terrible poetry but evidence of the same kind of murderous communist political ideology she was incarcerated for. She never had any remorse or regret for her terrorist record, including bombing the U.S. Capitol, a robbery involving the murder of two policemen and a security guard, and the escape from prison of cop-killer Joanne Chesimard. Consider the Buck poem on 9/11 poem, where she provides her Ward Churchill or Jeremiah Wright moment, talking about chickens coming home to roost and so forth.

Buck's release served as a rallying point for the terrorist networks that include Bill Ayers and Bernardine Dohrn. I was there in New York for the memorial service for this dead terrorist, where members of the Weather Underground and FALN paid tribute to this despicable figure. It was there that Buck's attorney, Harvard's Sofiyah Elijah, introduced an audio recording of BLA cop-killer Joanne Chesimard, now living in Cuba, talking about how her "sister" had obtained her freedom. "Freedom for Terrorists" seems to be a policy started under Clinton and continued under Obama.

The FBI files on the Buck case released to my group, America's Survival, Inc., provide more evidence of how these terrorists manipulate the legal system, as she became a fugitive while on a prison furlough. She started out, the documents show, as a left-wing student agitator active in communist and socialist groups who got heavily into dangerous drugs.

Larry Grathwohl will discuss how the active investigation into the 1970 Park Station bombing murder of Sgt. Brian V. McDonnell, is being turned *inactive* by this administration. It is yet another victory for terrorists. We are reminded of what happened two years ago when we launched our project "Justice for Victims of Weather Underground Terrorism," and all of the officers of the police union in San Francisco applauded our efforts in a letter and pinned the blame for McDonnell's murder on Bill Ayers and Bernardine Dohrn, only to be told by the Holder Justice Department to back off. Then Holder's Justice Department warned the police not to say anything because it might jeopardize an active investigation. Now we know that was just a ruse, a con job, in order to get the police to stop talking about the need to bring Bill Ayers and Bernardine Dohrn to justice. That means we have a problem in the Department of Justice at the top.

Many current and retired law enforcement members support our efforts. Jim Pera, retired Police Sergeant and one of the first on the scene of the bombing, was been most vocal in that regard, and we thank him. Dave Bowman, retired San Francisco Police Inspector, just on Saturday delivered a letter personally to the home of Bernardine Dohrn and Bill Ayers in Chicago which said, in part:

"This is to remind you once again that there is no statute of limitations for murder in the State of California. Many of us, and also the members of USA Survival, will continue to remind you until the time comes when the official murder charge is filed and the handcuffs are put on you."

In addition to prosecuting Ayers and Dohrn, there is an obligation to pursue the terrorist fugitives from justice here and in places like Cuba. But some are still at large in the U.S. We have wanted posters for these fugitives here today, and we urge the media to take this information directly to the public at large, so justice can be done. In the cases of some, however, it will require the effort and will of the U.S. Government to locate, apprehend and return them from Cuba to the U.S. That includes Joanne Chesimard of the Black Liberation Army and William Morales and Victor Gerena of the FALN and Los Macheteros. But how much commitment to justice can there be in a man, Holder, who facilitates pardons for terrorists, and under whose watch in the Obama Administration we have already seen one FALN terrorist and another Weather Underground/BLA terrorist be released?

The story of corruption in the Justice Department is not really a new story. We are releasing here for the first time the FBI file on CIA defector Philip Agee, who died in Havana after doing terrible damage to our intelligence efforts even while traveling to and from Cuba and the United States and never being prosecuted. The most clear-cut case against Agee was assembled under the Carter Administration and then dropped. The file shows that the FBI wanted him prosecuted for treason and espionage. It shows that Agee was a Cuban DGI and Soviet KGB operative. Agee got a free pass while those in the FBI who tracked down the terrorists and their support networks were prosecuted. Those terrorist support networks continue to exist to this day, as I witnessed personally when I covered that memorial service for Marilyn Buck in New York last November.

Communist Cuba continues to wage war on the United States, even while Obama continues to loosen restrictions on travel to and from the island nation – travel we know from the evidence provides a cover for terrorism and communist intelligence activities. Is it a coincidence that the attorney for Buck and Chesimard has been traveling to Cuba regularly? This is a subject that our final speaker, Humberto Fontova, will speak about in detail. I have run into Castro's operatives on several occasions in Washington, D.C., first when one of Castro's spies, Teofilo Acosta, praised the late Washington Post news editor, Laurence Stern, and more recently, when Juan Jacomino, second secretary of the Cuban Interests Section, was attending the Latin American Solidarity Conference to argue for release of the Cuban spies known as the Cuban five. We also discovered that Jacomino had been serving as a Cuban correspondent for Al-Jazeera, the terror TV channel that seems to be functioning as an intelligence-gathering arm and propaganda front for entities as diverse as the Muslim Brotherhood and the Cuban regime.

Cuba must remain on the list of state sponsors of terrorism. The U.S. policy must seek regime change in Cuba. Let President Obama use his new U.N.-approved policy of humanitarian intervention to protect the courageous dissidents in Cuba, being beaten up and tortured by the secret police of the regime. We call upon Obama to use the power of the U.S. Government to force the return, not only of the terrorist fugitives in Cuba, but of the kidnapped American hostage, Alan Gross, a foreign aid worker imprisoned by the Castro regime for trying to help ordinary Cubans communicate with the outside world.

We do not know how long the United States can suffer through this ongoing internal security crisis, with those at the top of our government not only being indifferent to the threat, but actually facilitating it.

We encourage the FBI's investigation of pro-terrorist so-called "solidarity groups," including in Chicago, where the Washington Post acknowledges, some of these "activists" had "crossed paths" with a politician named Barack Obama. We demand that Obama and Holder stay out of those investigations, even if the trail leads all the way into the Oval Office.

As for Congress, wake up. Do your job. Do your duty. We need new Congressional committees examining the internal security crisis we confront. This is not the time for golf games.
